

# Continuing Education/Continuing Medical Education (CE/CME) Resiliency Teacher Training

## Presentation Purpose:

Participants will be trained to teach Resiliency Training to other groups of healthcare professionals. To attend this course, previous attendance at a 6-hour Resiliency Training course is required along with a completed application. Attendees will have access to the Resiliency Training curriculum, and handouts, and will be guided in developing their skills to teach short, practical tools that can be used at the bedside or in the boardroom to manage stress.

## Learning objectives:

- Demonstrate how short resiliency tools can be used on the job to mitigate stress and burnout.
- Facilitate group discussions on job stress and resiliency skills.
- Explain key resiliency concepts: plimsoll line, awareness, self-compassion, how values safeguard resilience, empathy vs. compassion, and how to cultivate positive emotions.
